Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 13,130 Elia Group shares during the period between 20 September 2021 and 24 September 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 13,225 Elia Group shares.
