Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 9,190 Elia Group shares during the period between 8 November 2021 and 12 November 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 9,995 Elia Group shares.
