Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 7,035 Elia Group shares during the period between 10 January 2022 and 14 January 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 7,470 Elia Group shares.
