## Purchase and sale of Elia Group shares in the context of the liquidity agreement

### Regulated information

Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 13,539 Elia Group shares during the period between 21 March 2022 and 25 March 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 13,200 Elia Group shares.
