Purchase and sale of Elia Group shares in the context of the liquidity agreement

Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 11,934 Elia Group shares during the period between 11 April 2022 and 15 April 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 10,534 Elia Group shares.
