Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 9,242 Elia Group shares during the period between 10 February 2025 and 14 February 2025 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 9,164 Elia Group shares.
