## Purchase and sale of Elia Group shares in the context of the liquidity agreement

### Regulated information

Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 10,930 Elia Group shares during the period between 24 February 2025 and 28 February 2025 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 9,904 Elia Group shares.
